No.270 of 2010 along with OA 24 of 2010.

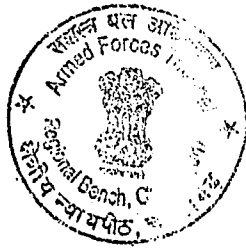
We may recall that in the order dated 14.9.2010, it was also noticed that the matter before the Principal Bench was fixed on that date. In that view of the matter, all these petitions are decided on the same lines for the same reasons granting same reliefs and to the same effect as done by the Principal Bench in O.A.No.270 of 2010.

However, if any of the petitioner individually feels that his grievance had not been adjudicated in the judgment of the Principal Bench, it would be open to the individual petitioner (not in body), to seek appropriate relief.

In OA Nos.314, 326, 445 and 476 of 2010 costs have not been deposited so far, be deposited within a period of two weeks, failing which necessary steps be taken for effecting recovery.
