**Subject:** Revision of pension w. e. f. 1.1.2006 & 1-1-2016 of Pre-2006 pensioners who retired from the 5<sup>th</sup> CPC scale of Rs.6500-10500 – Reg Revision of Fitment Table as per 6<sup>th</sup> CPC and Concordance Table as per 7<sup>th</sup> CPC for Revision of Pension of Pre-2006 Pensioners who retired from 5<sup>th</sup> CPC Pay Scale of Rs.6500-10500 or equivalent in earlier CPCs.

In continuation of our Memorandum dated 10-1-2019, cited above, and while reiterating the submissions made therein for an early decision for a minimum Revised Pension of Rs.9230 to all those who retired from the 5<sup>th</sup> CPC Pay Scale of Rs.6500-10500 or its equivalent scales in earlier CPCs in accordance the orders of the DOP&PW & DOE judgement of CAT cited above;

We earnestly request that orders in respect of the following related issues may also please be issued to provide early relief to senior and super-senior citizens who have been waiting for justice in this regard for the last more than ten years.

- i) Revised Fitment Table for fixation of Revised Pension from 1-1-2006 with Rs.4600 Grade Pay may please be issued in respect of Pre-2006 pensioners who retired from the 5<sup>th</sup> CPC scale of Rs.6500-10500 in the corresponding Scale of Rs.7450-11500.
- ii) Concordance Table for Revision of Pre-2016 Pensioners, issued after 7<sup>th</sup> CPC vide DOP&PW OM dated 6-7-2017, may please be revised as per Level 7 as for Grade Pay of Rs.4600 in Seventh CPC Pay Matrix for those who retired from 5<sup>th</sup> CPC Pay Scale of Rs.6500-10500 or its equivalent scales in earlier CPCs.
