MINUTES OF GENERAL BODY MEETING OF RSCWS HELD ON 26-11-2022 AT GOVT. MUSEUM AUDITORIUM, SECTOR 10, CHANDIGARH

- A) Sh KP Singh, President RSCWS, presided with 54 Members attending the Meeting.
- B) <u>Condolences:</u> To start with,two minutes silence was observed in the memory of Members who left us forever in 2022.
- C) Observance of Constitution Day: The Meeting started with a pledge by the Members by reciting the Preamble of the Constitution to abide by the Constitution of India as advised by the DoP&PW.
- 1. Opening address by the President/RSCWS Sh. K.P.Singh:

President welcomed the members and expressed his concern about the thin attendance.

- 2. Report of the Secretary General/RSCWS
 - 2.1 The SG expressed regret for the delay in holding the GBM because of slowed co-ordination due to his illness and being out of station for long.
 - 2.2 RSCWS is always taking up the pensioners' issues regarding pension and healthcare facilities at all levels, especially the empanelment of private hospitals and pursuing clearances of outstanding payments of these hospitals and now some of the hospitals (including MAX Mohali, IVY Mohali, Grecian Mohali, Indus Mohali, Mukat Chandigarh and DrishtiPanchkula) are giving cashless treatment to the Railway beneficiaries.
 - 2.3 However, Fortis Mohali and Shri Guru Harkishan Sahib Multi specialty Hospital, Sohana have stopped cashless treatment to Railway beneficiaries due to alleged heavy deductions from their bills by the Railways.
 - 2.4 Six hospitals in the tricity are giving treatment at CGHS rates to Members of RSCWS on cash payment which is a matter of relief for the members, especially in non-referral cases & for those who had not joined RELHS.
 - 2.5 Previously Railway Beneficiaries & their relatives had to go to CMS/UMB for referral to empanelled Hospitals and for approval of treatment in emergency in private empaneled Hospitals. Now, as per revised orders issued by the Railway Board & the NR, the referral will be made by the ADMO CDG and in case of emergency ADMO/CDG will seek telephonic approval of CMS/UMB within 24 hrs. for treatment in empaneled hospitals.
 - 2.6 Ten major ailments already circulated in the PRS are considered as emergency; for the rest we have to seek referral of Rly Doctor for treatment in the empaneled hospitals.
 - 2.7 The present CMS/UMB is quite cooperative in ensuring the availability of Railway Doctor at HU/CDG for five days from Monday to Friday which was previously two days a week due to maternity leave of the regular ADMO/CDG.
 - 2.8 With the efforts of RSCWS, revised PPO of Sh.H.S.Sachdeva was got issued and an arrear of Rs. 7 Lakhs paid to Sh.H.S.Sachdeva.
 - 2.9 RSCWS is regularly updating the knowledge of the pensioners on healthcare related issues and pension related matters.
 - 2.10 We all should come forward to strengthen the RSCWS so that we can fight for the causes of pensioners in getting their due rights.
 - 2.11 SG thanked Sh. R.K.Dutta for carrying out Digital Life Certificates of the pensioners who are unable to go to the banks for any reason.
- 3. Presentation of Audited Balance Sheet for the year 2021-2022 by Finance Secy. Sh. Jaspal Singh Audited balance sheet for the financial year 2021-22 was presented and approved by the members.
- 4. Medical Seminar

Dr. SaloniGarg BDS, dentist, gave a very useful presentation on dental problems, oral hygiene and dental care in old age. After the presentation a question answer session was held for further clarifications of the queries of the members.

- Charter of Demands by RSCWS
 Charter of demands was placed before the members and was approved for further action.
- 6. SwachhtaAbhiyan: a) SG informed that as advised by DoP&PW, all pensioner's associations had to participate in SwachhtaAbhiyan in October, 2022 to promote the cleanliness. In this regard RSCWS donated four sets of mops, wipers, brooms and wet swabs costing Rs. 2802/- from its Social Welfare Fund to Govt. Model High School, MauliJagran, Chandigarh and counselled around one hundred students, along with their teachers about the importance of cleanliness and how to achieve the same in our day-to-day life.
 - b) As a part of cleanliness drive and in consultation with the school management, it was proposed that RSCWS also donate a Grass & Bush cutting (Mowing) Machine to the above said School from its Social Welfare Fund, for better environment and all round swachhata of the premises & its grounds. General Body unanimously approved this proposal. and authorized the EC to finalize the suitable design, size &

Price (about or less than Rs.10,000/- as the case may be)of the Machine and to donate the same to the said School on behalf of RSCWS.

7. Introduction Of New Members: -

Sixteen new members enrolled during last six months, were introduced and welcomed.

8. Sh. C.S.BajwaEx.Divisional Secretary NRMU/UMB who retired on 31-10-2022 and

Sh. Nirmal Singh, the current Divisional Secretary NRMU/UMB, were welcomed to the Meeting by the SG as Special Invitees.

Sh. Nirmal Singh assured to raise the problems of tricity pensioners with the concerned authorities in UMB division regarding:(i) Issue of UMID card to the pensioners ii) upgradation of Health Unit/CDG to Sub Divisional Hospital with facilities of indoor treatment to Railway Beneficiaries iii) Releasing of undue recoveries from bills of empanelled hospitals; this particular hold up is causing inconvenience to the Railway beneficiaries)

He requested SG/RSCWS to give in writing all the concerned issues for proper follow up.

Sh. C.S.Bajwa addressed the General Body/RSCWS and assured all his support and asked that the following Lists & details of other problems be sent to him for pursuing the same with the concerned authorities.

- i) List of pensioners who have not yet been able to get the UMID card.
- ii) List of pensioners who have not yet got their revised PPOs as per 7th CPC.
- 9. Concluding Address by Sh. KP Singh, President/RSCWS:
 - 9.1 Sh. KP Singh expressed his happiness for organizing the annual GBM and medical seminar.
 - 9.2 Appreciated the efforts of SG/RSCWS for releasing of PRS and storing all important information at one place for the convenience of pensioners.
 - 9.3 He appreciated that SG/RSCWS helped the pensioners in getting cashless treatment.
 - 9.4 Thanked the executive especially Sh. R.K.Dutta for conducting digital life certificates for sick and needy pensioners at home.
 - 9.5 He proposed that RSCWS should add an obituary column in its journal "Pensioners Rail Sampark" to remember the departed members.
 - 9.6 Names of members who donate more than Rs. 500/- for Social Welfare Fund to be included in the PRS.
 - 9.7 An encouragement should be given to members to share/write their experiences and these should be included in the PRS.
 - 9.8 Younger members to be included in the executive so that society should run with pace of the time.
 - 9.9 Health check-up camps should also be organized for the members at least twice a year.
- 10. Vote of thanks by SG/RSCWS

CHARTER OF DEMANDS OF RSCWS.

PART 1: MAIN DEMANDS OF RSCWS

- 1) Implementation of the following Recommendations of 110th Report of Parliamentary Committee;
 - a) Additional Pension of 5% after 65 years of age, 10% after 70 years of age & 15 after 75 years of age. (Para 3.28).
 - b) Fixed Medical Allowance of Rs. 3,000/- P.M. instead of Rs.1,000/- P.M. (Para 3.21)
 - c) Upgrading of Medical Facilities to Pensioners at par with serving employees. (Para No. 3.23).
 - d) Grant of MACPS from 1.1.2006 instead of 1.9.2008). (Para 3.35)
 - e) Increase in Grant in Aid to Pensioners Associations. (3.31).
 - f) Treatment in Non-empaneled Hospitals in exigencies. (Para No. 3.19)
 - g) Settlement of Medical Facilities related Grievances on CPENGRAM Portal (Para 3.20).
 - h) Reconsideration of other points on which negative Replies have been given in 120th Report of Parliamentary Standing Committee on Pensioners grievances.
- 2) Restoration of 3 Slabs of DA (Dearness Allowance deducted for the period January, 2020 to July. 2021).
- 3) Restoration of Commuted portion of Pension after 12 years instead of 15 years in view of steep fall in rates of Interest.
- 4) Revision of PAY structure & Pension of Central Government employees & Pensioners every 5 years instead of every 10 years, in view of heavy inflation beyond the unrealistic prescribed price index and major economic changes during the existing period of 10 years.
- 5) Compatibility of Principles & Policy for determination of Pay, Allowances and Pension of MPs and Central Govt. Employees to ensure equity as per fundamental rights under article 14, 16 and 39 of the Constitution of India.
- 6) Grant of 50% of pay as pension after 10 years of service instead of 20 years of service at present to Central Government Employees, in order to ensure equity and justice under article 14, 16 & 39 of the Constitution although the MPs are given a Pension on completion of 5 years or even for a lesser period.
- 7) Extension of Old Pension Scheme to the employees recruited from & after 1st
- January 2004 at par with Pre 2004 employees instead of New Pension Scheme to ensure equity & justice.
- 8) Treatment of Railway Beneficiaries in Ayushman/CGHS/ECHS Hospitals & Dispensaries & in their Empaneled Hospitals all over India in reciprocity to the other Central Government employees / Ayushman Beneficiaries getting treatment in Railway Hospitals.
- 9) Exemption of FMA (Fixed Medical Allowance) from Income Tax under Section -80 D of IT Act.

Part 2: Demands of Chandigarh Tricity& surrounding areas

- 1. Upgrading of Health Unit NR Chandigarh to Sub-Divisional Hospital with adequate accommodation for requisite number of doctors, para -medical staff & investigation facilities like X- Ray & Pathological Lab etc. at an easily accessible Location near Chandigarh Railway Station under the Modernization Plan.
- 2. Provision of Health Unit or at least Lock -up dispensary at or around Mohali Railway Station as the existing Health Unit Chandigarh is nearly 20 to 30 Kilometers from the residence of a large number of Railway employees & Pensioners settled in Mohali & its surrounding areas up to Kharar, Kurali&Morinda.
- 3. a) Local Purchase of Medicines from the Tricity for Tricity based Pensioners instead of getting the same purchased from Ambala,
- b) Developing a system to avoid double trip to the Health Unit for getting the prescribed medicines especially for the Chronic diseases.
- 4. a) Empanelment of More Private Hospitals in Chandigarh &Panchkula as large number of employees & Pensioners are settled there. including Paras Hospital, Sector 22, Panchkula; Ojas Hospital, Sector 26, Panchkula; Grewal Eye Institute, Sector 9, Chandigarh, JP Eye Hospital, Phase 7, Mohali.
- b) Revival of empanelment of Shri Guru Harkrishan Sahib Super Specialty Hospital, Sohana and Fortis Multi Specialty Hospital, Sector 69, Mohali.

RAILWAY BOARD & DOP&PW ORDERS

Copy of Railway Board's OM No. PC-V/2016/A/Med/1(FMA)(E) Dated 27-10-2022 (RBE No. 137/2022) to all General Managers & Others.

Sub: Grant of Fixed Medical Allowance to Railway pensioners/family pensioners-change in option.

In terms of Railway Board's letter No. PC-V/98/I/7/I/I dated 15-7-2002 (RBE No 107/2002), the Railway pensioners/family pensioners eligible to opt for FMA had been provided, once in a life time, an opportunity to change their option to avail the benefit of FMA or otherwise on furnishing proof of change in residence. The issue of allowing this one-time opportunity to change option for FMA/OPD facility had been under consideration with DoP&PW for quite some time. It has now been decided that the Railway pensioners/family pensioners residing beyond 2.5 kms from Railway Hospital/I-lealth Unit and eligible for RELHS shall be allowed opportunity to avail change in option, once in a time, from FMA to OPD or vice versa without linkage to change in residence.

This issues with the concurrence of Finance Directorate of Ministry of Railways.

3. This will come into effect from the date of issue of this letter.

Sub: Reservation on Railway Passes/PTOs

Ref: Letter No. 94/TG-V20/P/14 dated 28.08.2009 (CC No. 39 of 2009)

Instructions were issued vide letter referred to above, stipulating detailed guidelines on booking of tickets on railway Passes. Consequent to introduction of facility for online booking of reserved tickets on railway Passes/PTOs issued through HRMS and also on receipt of requests for revising the guidelines for ticket booking on PTOs, the matter has been reviewed and it has been decided that the procedure to be followed for booking reserved tickets on the authority of Railway Pass [PTO will be as under:

- i. Pass/PTO holders or their representatives should present their passes/PTO along with the requisitions duly filled in to the Reservation Clerk who will issue ticket on realization of due fare, if any, and make endorsement on the face of the pass/PTO indicating the PNR number, the train number, date of journey, status of tickets, etc.
- ii. The option to book reserved tickets online on the authority of Railway Pass/PTOs can also be availed for that category of pass/PTOs for which the same has been provided by CRIS/IRCTC.
- iii. Holders of Privilege, Duty, Post Retirement, Complimentary, Metal and other passes/PTOs may be allowed to seek fresh reservation only if the earlier reservation is cancelled before preparation of first reservation charts. The ticket booked across the computerized Passenger Reservation System (PRS) counter can also be cancelled through website of IRCTC within the stipulated time period prescribed in the Refund Rules. In such cases, it will not be mandatory to surrender the ticket across the PRS counter, if no refund is due. However, in case of due refund amount involved on tickets booked on pass/PTOs, surrender of original ticket across the reservation counter within the prescribed time limit shall be mandatory.
- iv. In case of confirmed reservation on privilege, Post retirement, complementary and other passes/PTOs, the pass/PTO holder can make maximum three-time reservations provided the earlier one has been cancelled before preparation of first reservation charts, failing which the the pass/PTO will be treated as used.
- v. There will be no restriction in number of cancellations in case of Duty Pass, Metal Pass and in case of tickets having a status of fully/partially waiting list (at the time of cancellation) against Privilege, Post Retirement and Complimentary passes/PTOs. However, fresh reservation will be given only after the earlier one has been cancelled within the normal prescribed time limits, which at present for waitlist/RAC/partially confirmed tickets is 30 minutes before scheduled departure of train.
- vi. Telephonic requests for reservation and cancellation will not be entertained
- vii. The portion of break journey will be treated as separate journey i.e., instructions contained at para (iii) and (iv) will be applicable for each leg of journey separately.
- viii. It will be the responsibility of officer/staff making reservation on Metal/Duty Passes to ensure that between the same stations and on the same date, reservation should not be made in two separate trains.
- ix. The facility of modification of ticket booked on PTOs will not be available.
- x. In case of PTOs, cancellation/clerk age charge as applicable shall be levied on each time of cancellation as per existing principles on cancellation of tickets booked on PTOs. However, after enabling this option no modification option shall be allowed on PTOs issued across HRMS.
- 2. CRIS will make necessary modifications in the software as required.
- Sub: Change in scheme under FMA Copy of S.Rly Letter No. P(W)/UMID/FMA Option dated 30.11.2022)

Ref: - RBE=137/2022(PBC-216/2022 and PBC-239/2022)

In view of the above Board's letter and PBC's, it has been decided to provide an onetime option to pensioners and family pensioners for change of option for FMA or OPD without linkage to change of residence.

Similar option was also made available earlier, at that time without the sanction of the Railways, FMA had been allowed automatically by Banks, this has resulted in some problem in issuance of the UMID card to the employee regarding eligibility for OPD.

Hence, to avoid such situation the following guidelines are issued for information and compliance.

- 1. Option forms as circulated vide PBC No. 239/2022 dated 10.11.2022 should be submitted by the pensioner of family pensioner to the Personnel Branch of the Division/Workshop/Unit concerned.
- 2. On submission of the same sanction of Competent Authority shall be obtained a sanction memorandum has to be issued.
- 3. On the basis of the sanction memorandum, only FMA or OPD can be claimed.
- 4. This should be ensured by the Account Department by issuing Letter of Authority to the banks concerned in every individual case duly endorsing a copy to Personnel Branch (UL-3).
- 5. No banks should be allowed to disburse FMA directly on their own, since change of option as have effect on the UMID cards issued.
- 6. The copy of the sanction memorandum issued be enclosed to the dealer or inspector who deals with the UMID card should make necessary changes to issue revised UMID card (UL-3). Based on that, the dealing clerk or the inspector who deals with UMID card should make necessary changes to issue revised UMID card stating that the pensioner is eligible for FMA or otherwise as per the revised option.

Sub: - Clarification regarding whether deductions towards commutation are required to be made from family pension for the remaining period in cases where the pensioner dies before the restoration of commuted-reg

In accordance with Rule 5 of CCS (Commutation of Pension) Rules, 1981, a Government servant can commute for a lump-sump payment of an amount not exceeding 40 per cent of this pension. Further, in accordance with Rule 10-A of CCS (Commutation of Pension) Rules, 1981 the commuted amount of the pension shall be restored on completion of fifteen years from the date of reduction of pension on account of commutation becomes operative in accordance with date of reduction of pension on account of commutation becomes operative in accordance with Rule 6.

- 2. References/representation have been received in this Department seeking clarification whether deduction towards commutation is required to be made from family pension for the remaining period in cases where the pensioner dies before the restoration of commuted pension.
- 3. It is clarified that in such cases monthly commuted amount of pension is not required to be deducted from family pension shall be paid in full without any deduction in this regard.

Sub: Restoration of Commuted Portion of Pension to Central Government Pensioners after 12 years of Commutation instead of 15 years as at present.

- 1) We draw kind attention of the Government and seek your benign intervention towards the injustice being done to the Central Government Pensioners in respect of Restoration of Commuted portion of Pension, being done after 15 years of the Commutation.
- 2. The 5th CPC, in para 136.10 recommended that the commutation value in respect of employees superannuating at the age of 60 years and commuting a portion of pension within a period of one year, would be equal to 9.81 years' (purchase). After adding thereto, a further period of two years for recovery of interest, it would be reasonable to restore the commuted portion of the pension after 12 years, instead of 15 years as at present.
- **3.** These recommendations of the 5th Pay Commission were not implemented by the Government even though the rates of Interest have been drastically reduced over the years
- 4. Life Expectancy: Average life expectancy between the period 2002-06 and 2013-17 increased by 5.7 years.

- 2. The interest on commuted value of pension is recoverable in 2.66 years. Take an Example ,of a 60 years retiree; Age Next birthday is 61 years, then the commutation value is 8.194. Thus, total recovery period of the commuted amount is = 8.194 + 2.66 = 10.85 years. Even after full recovery, the pensioner keeps on paying for 15 10.85 = 4.15 years. Thus, excess recovery is taking place for 4.15 years. This is very unfair as the recovery of the commuted value of Pension is Completed in 10.85 years.
- 3. It is, therefore, requested that considering the sweeping changes in the interest rates, and increase in life expectancy, Commuted Portion of Pension may please be restored to the Pensioners after 12 years of Commutation thereof.
