### IMPORTANT GUIDELINES FOR APPLICANTS

\* Mark Status as applicable – Member / Life Member / Associate Member

Who can be MEMBERS of RSCWS Rates of Subscription as applicable w.e.f. 2018:

- i) Any retired Railway official or a spouse of a deceased Railway official shall be eligible to be a Member of the Society
- ii) Any Railway official between the age of 55 to 60 years may become an Associate Member of the Society
- iii) a) Subscription for Members of the Society - residing in Chandigarh, Mohali, Panchkula, Zirakpur or their out- skirts – shall be Rs. 300 per annum OR Life Membership shall be Rs.2500/-.  
b) Subscription for the Members of the Society residing outside Chandigarh, Mohali, Panchkula, Zirakpur or out-skirts – shall be Rs. 100 per annum OR Life Membership shall be Rs.1250/-.
- iv) Subscription for the Associate Members of the Society shall be Rs. 100 PA
