ALL SLPS OF GOVT DISMISSED BY SUPREME COURT AGAINST MODIFIED PARITY TO PRE 2006 PENSIONERS

All SLPs of the Govt. against Modified Parity to Pre 2006 Pensioners were DISMISSED by the Supreme Court on 17-3-2015 - paving the way for affected Pensioners to get Arrears from 1-1-2006 to 23-9-2012 instead of from 24-9-2012 onwards - as per DOP&PW orders Dated 28-1-2013. Govt. had sought four months time for implementation of the verdict - to which the SC court finally agreed.

CHAIRMAN 7TH PAY COMMISSION ASSURES JCM (STAFF SIDE) TO WRITE TO GOVT TO SEEK CLARIFICATION ON INTERIM RELIEF & DA MERGER

Representatives of JCM Staff Side met the Chairman 7th Pay Commission on 25.02.2015 and demanded for Interim Report on merger of DA and Interim Relief. Chairman said that Commission had no such Term of reference. However, Chairman agreed to write a DO letter to the Govt. conveying strong feelings of staff side JCM. Pay Commission assured that it will submit its report within stipulated time to the Government (i.e. by September, 2015).

CG EMPLOYEES LIKELY TO GO ON STRIKE IF DEMANDS ARE NOT MET

Central Government employees may go on an Indefinite Strike if the demands for DA Merger, Interim Relief etc. are not met, as per decision taken in a joint meeting of JCM Staff Side. Final decision on it will be taken after a Rally before the Parliament at Delhi on April 28.

Department of Pension – CPAO (vide its letter dated 30-1-2015) – while reiterating its earlier orders issued vide Correction Slip Nos. 14 & 22 to Scheme of Payment of Pension to Central Government Civil Pensioners by Authorised Banks) have directed all Banks not to insist on Personal Presence of Pensioner for Live Certificate to be given every year in November, if the Live Certificate is submitted duly signed by specified authority including Aadhar Based authentication. Under the 'Digital India Mission', Govt. has launched 'Jeevan Pramaan - an Aadhaar based Digital Life Certificate' for pensioners on 10.11.2014. This facility provides an option to the pensioners to submit their life certificate digitally by authenticating biometrically using UIDAI Database. The pension disbursing agencies integrated with the Jeevan Pramaan Portal will get access to digital life certificate. The pensioners need not go to the pension disbursing agency in person.

MINUTES OF AGM RSCWS HELD ON 9-1-2015 AT YWCA, SECTOR 11, CHANDIGARH

- 1. Sh. N. P. Mohan presided over the meeting, which was attended by ----- Members.
- 2. Inaugural address by the President: Sh. N. P. Mohan mentioned the following points in his address:
 - I) Requested to Members to contact their colleagues & friends for membership of RSCWS.
 - II) Need for liberal & regular contributing to SWF (Social Welfare Fund) of RSCWS.
 - III) Delay in grant of revision of pension as per modified parity to pensioners due to unjust continuation of 3 SLPs filed by the Govt in the Supreme Court. Unfortunately hearing of these SLPs had not taken place for a long time as this case was appearing lower down in the cause lists so far.
- 3. <u>CONDOLENCES & TRIBUTES TO THE DEPARTED MEMBERS</u>: Glowing tributes were paid and two minutes silence was observed in memory of Late Sh. M. S. Batra Chairman & Founder President RSCWS and Late Sh. K. S. Bhandary Vice President (earlier Treasurer RSCWS) and Late Sh. Sukhdev Singh Joint Secretary RSCWS, for their long and dedicated service to the Society.
- 4. <u>SEMINAR ON DIET & NUTRITION</u>: A) Meeting started with a Lecture on "DIET & NUTRITION MANAGEMENT IN OLD AGE" by Harleen Bakshi, Clinical Nutritionist, Fortis Med Centre, Chandigarh. (Excerpts from her speech will appear as an article on Page 6 of this issue of PRS) followed by an inter-action with the Members).
- **B)** Introduction about Fortis Med Centre, Chandigarh: Ms Rupinder Kaur, In charge Fortis Med Centre, Sector 11, Chandigarh, gave an introduction about the activities of the newly started Centre by Fortis Health Care and the Facilities available therein. While referring to the long association with RSCWS, she informed about the decision of the Fortis Management to offer some special concessions to the Members of RSCWS.

RSCWS AGAIN URGES CMD REG. MEDICAL & HEALTH CARE PROBLEMS IN TRI-CITY

Copy of Letter No. RSCWS/HO/CMD/2014-15 Dated 12-3-2015 to CMD/NR/NDLS

Sub: Serious Medical & Health Care Problems of Railway Beneficiaries at Chandigarh

Please refer to our Memorandum dated 9/5/2014 followed by reminder dated 10/6/2014, regarding Problems of Pensioners at Chandigarh, wherein your kind attention was invited to the lack of Medical facilities for over 4000 Railway Beneficiaries - including Pensioners and others - at Chandigarh. We had earnestly requested you to ameliorate the suffering and hardship being faced by them. It is regretted that the following problems are still left unresolved, thus causing much hardship to the patients who are Railway Beneficiaries:

- 1. Most Medicines are either NOT AVAILABLE or OUT OF STOCK most of the times.
- 2. Powers for Local Purchase have not yet been given to Doctor at Health Unit Chandigarh.
- 3. Issue of Medicines prescribed by Specialists gets delayed due to non availability of powers for Local Purchase.
- 4. Separate Budget has not yet been sanctioned for Health Unit at Chandigarh.
- 5. 1 post of Pharmacist, 1 Dresser, 2 Attendants (One Male & one Female) are still lying VACANT.
- 6. Fans, Water Cooler with RO for the Patients has not yet been provided.
- 7. 3 Rooms of Health Unit have forcibly been occupied by Dy. CE(Const)/CDG Office and by the P-Branch staff of UMB-Division causing difficulty to the patients and create hindrance in the working of Health Unit.
- 8. No Dressing Room, Store Room and Toilet facility have been provided for Patients visiting the Health Unit as a result of uncalled for occupation of the above said rooms.
- 9. Empanelment cases of Fortis, MAX & Sohana Hospitals are pending since long creating major hardship to serious cases requiring specialized treatment. These proposals need to be considered and approved early.
- 10. Powers for referral cases to PGI & Private Hospitals be given to the Doctor at Chandigarh.
- 11. Diagnostic facilities are not provided in Health Unit nor any out-source Agency nominated or Empanelled

It is, therefore, once again requested to please look into these problems and issue necessary orders and approvals in this regards early so that the Health Unit at Chandigarh functions with requisite facilities as per established norms.

- 10.Swachh Rail Swachh Bharat, new department for cleanliness.
- 11.NIFT to design linen; online booking of disposable bed rolls:
- 12. Identified trains be augmented to run with 26 coaches.
- 13.1000 MW solar plants will be set up by the developers.
- 14.7,000 kms of double/third/fourth lines and commission 1200 km in 2015-16
- 15.800 km of gauge conversion targeted in current fiscal.
- 16.77 projects covering 9,400 km of doubling/tripling/quadrupling works along with electrification.
- 17. Traffic facility works with outlay of Rs. 2374 crores.
- 18.6,608 route kilometers to be electrified for 2015-16
- 19. Developing Satellite Railway terminals in major cities.
- 20. Speed of 9 railway corridors to be increased from existing 110 and 130 kmph to 160 and 200 kmph.

<u>Judgement of Supreme Court Dismissing all SLPs of Govt Reg Modified Parity to Pre 2006 Pensioners</u> Delivered by Justice. T.S. Thakur & Justice R. Banumathi on 17th March, 2015

SLP(C)Nos.36148-36150 of 2013, SLP(C)No.16780-16782 of 2014 & SLP(C) Nos...........of 2015 (CC Nos.16903-16904):

"We see no reason to interfere with the orders impugned. The special leave petitions are accordingly dismissed. Ms. Pinky Anand, learned Additional Solicitor General, however submits that in view of the nature of the controversy as also the extent of financial burden arising out of the implementation of the impugned orders, the petitioners-U.O.I. may be given reasonable time to do the needful. That prayer is not opposed by counsel opposite. We accordingly grant four months' time from today to the petitioners to comply with the impugned orders failing which the contempt petitions pending before the Tribunal can be revived by the concerned petitioners and taken to their logical conclusion. All impleading and intervention applications are also dismissed."

Brief Note by N. P Mohan Ex-CE WR & President RSCWS

Modified Parity to Pre 2006 Pensioners: FOR WHOSE BENEFIT & TO WHAT EXTENT?

A number of long pending SLPs against the judgements of CAT/HC & AFT were dismissed by SC by order dated 17-3-2015 of which <u>SLP (C) Nos. 36148-36150 of 2013</u> pertain to civilian pensioners... What benefit accrues to pre- 2006 pensioners with dismissal of these 3 SLPs is explained below:

1. <u>REASONS FOR LEGAL COURSE TO GET RIGHTFULL PENSION</u>: While implementing the accepted recommendations of 6th CPC, the Govt (vide orders dated 3-10-2008) misinterpreted the same by equating minimum of pay in the PB corresponding to pre revised pay scale to minimum of the PB IRRESPECTIVE of pre-revised scale of pay and applying it uniformly to all scales in the PB resulting in reduction of pension varying from scale to scale.

2. LEGAL COURSE:

- i. Pensioners Association of S 29, comprising 660 retirees from various Groups 'A' Central Services (affected the most) were granted relief by unanimous judgement by Full Bench of PB CAT New Delhi on 1-11-2011. Respondents were directed (vide Para 30 of CAT Judgement) to re-fix the pension of all pre-2006 pensioners as per Resolution dated 29-8-2008 (accepted recommendations) within 3 months This verdict was common to 4 OAs grouped with the lead application (OA 655/2010.) of S 29 group.
- ii. UOI filed WP (C) in March 2012 against the verdict of CAT in Delhi High Court which was dismissed on <u>29-4-2013</u> upholding decision of Full Bench of the Tribunal.
 - In the mean time, DOP vide OM dated 28-1-2013 stepped up the minimum pension of all pensioners in accordance with fitment table from an arbitrary date of <u>24-9-2012</u>. This fact was noted by DHC by observing that "In short, the GOI has tacitly admitted that it was in the wrong and that the Tribunal is correct."
- iii. Instead of implementing DHC orders, in one case of OA (655/2010), UOI filed SLP in SC which was dismissed on 29-7-2013 at the preliminary stage itself. This was followed by filing of Review Petition dismissed on 12-11-2013 and CURATIVE PETITION which was also dismissed on 30-4-2014 by 5 Judge Bench of the Apex Court, headed by CJI.
- iv. Thereafter, PB CAT, while discharging contempt petition on <u>15-5-2014</u>, directed Govt to implement the directions of the Tribunal. The implementation order by the Govt was, however, restricted to only 660 petitioners of S 29 petitioners in OA 655/2010. In the mean time, UOI filed 3 SLPs against the common judgements & orders of CAT & DHC. Upon hearing the said SLP on 19-11-2013, Apex court ordered for listing along with civil appeals filed against AFT judgments.

It was only after nearly 1 ½ years on 17-3-2015 that SC has dismissed 3 SLPs cited above.

3. <u>BENEFIT TO PENSIONERS BY DISMISSAL OF SLPs</u>: In its judgement (given above), the court sees no reason to interfere with the orders impugned. These orders refer to PB CAT verdict of 1-11-20 11 and DHC judgement of 29-4-2013. The quantum of minimum pension for each pay scale is already fixed from 24-9-2012 in accordance with the verdict of Tribunal. The same stands to be paid now from 1-1-2006* for which 4 months period is allowed up to <u>17-7-2015</u>. It is now to be seen as to how soon the orders of the SC are implemented by Govt or the harassment of old pensioners (none less than 69 years) will be perpetuated further by resorting to Review and Curative Petitions.

Time limit for Advance Reservations increased to 120 days

Railway Board's Letter No. 2007/TG-1120/P dated 27.02.2015 to Chief Commercial Managers, All Zonal Railways. (COMMERCIAL CIRCULAR NO. 11 OF 2015)

Sub: Time limit for Advance Reservations.

- It has been decided to increase the advance reservation period from 60 days to 120 days (excluding the date of journey) w.e.f. 01.04.2015. CRIS will make necessary changes in the software for this purpose under intimation to all Zonal Railways as well as Board's office.
- 2. There will be no change in case of certain day time Express Trains like Taj Express, Gomti Express, special trains, etc. where lower time limits for advance reservations are at present in force. There will also be no change in case of the limit of 360 days for foreign tourists.
- 3. Board desire that the above change may be given wide publicity well in advance of its implementation.

 Suitable instructions to all concerned may be issued to ensure smooth change-over to the new time limit.

VALIDITY OF PRIVILEGE PASS & PTO ARE AUTOMATICALLY TO BE FIVE MONTHS WHEN ADVANCE RESERVATION PERIOD INCREASES TO 120 DAYS

Ref: RBE No: 41/2012, dated 26.03.2012, Pass Rules, 1986 Item 3 (IV) (V) of Schedule-II

- (I) A half set or one set of Privilege Pass shall be valid for one month more than the advance reservation period, i.e. Five months at present, from the date of issue irrespective of whether the inward journey is for the same station or any other station.
- (II) Privilege Ticket Order (PTO) shall be valid for one month more than the advance reservation period, i.e. Five months at present, from the date of issue.
