छठे केन्द्रीय वेतन आयोग की सिफारिशों के आधार पर, रेल सेवा (संशोधित वेतन) नियम, 2008 को लागू करने के परिणामस्वरूप, रेलों पर अप्रेंटिसों और प्रशिक्षुओं (अराजपित्रत) की स्टाइपेंड की दरों में संशोधन का मुद्दा विचाराधीन था। अब, राष्ट्रपित जी सहर्ष इसके साथ संलग्न अनुसूची के अनुसार अप्रेंटिसों और प्रशिक्षुओं की स्टाइपेंड की दरों में संशोधन करते हैं।

- 2. यह संभावना है कि कितपय रेलों पर अप्रेंटिसों की कुछ मौजूदा कोटियों के पदनाम संलग्न अनुसूची में दर्शाए गए अनुसार एकसमान नहीं हैं। इन मामलों में, रेल प्रशासन विस एवं मुलिध के परामर्श से, अनुसूची में दर्शाए गए समान मामले से संबंधित अप्रेंटिस का पदनाम/कोटि की पहचान करें और उसके बाद लागू स्टाइपेंड की दर को विनिश्चत करें। जहां कहीं इस प्रकार की पहचान करना संभव नहीं है, वहां उन विशिष्ट मामलों को विस एवं मुलिध की शब्दशः टिप्पणियों सहित बोर्ड को भेजें।
- 3. यदि, एक या अधिक कोटियों के संबंध में इन आदेशों में यथोल्लिखित प्रशिक्षण की अविध वास्तिवक पद्धित से भिन्न है, तो मामले को निर्णय हेतु रेलवे बोर्ड को भेजा जाना चाहिए।
- 4. अप्रेंटिस और प्रशिक्षु स्टाइपेंड की संशोधित दरों के लिए उपयुक्त महंगाई भत्ते की संशोधित दरों को आहरित करेंगे।
- 5. स्टाइपेंड की संशोधित दरें 01.09.2008 से प्रभावी होंगी।
- 6. इसे रेल मंत्रालय के वित्त निदेशालय की सहमित से जारी किया जा रहा है.

Consequent upon the promulgation of Railway Services (Revised Pay) Rules, 2008 on the basis of the recommendations of the Sixth Central Pay Commission, the issue of revision in the rates of stipend to apprentices and trainees (non-gazetted) on Railways was under consideration. Now, the President is pleased to revise the rates of stipend to the apprentices and trainees as per the schedule attached herein.

- 2. It is likely that some of the existing categories of apprentices on certain Railways may not have designations identical to what appears in the enclosed Schedule. In such cases, the Railway administration, in consultation with FA & CAO, should identify the designation/category of the apprentice concerned with similar case appearing in the Schedule and determine the rate of stipend applicable thereto. Wherever such identification is not possible, specific cases may be reported to the Board with verbatim comments of the FA & CAO.
- 3. In case, the period of training as indicated in these orders is at variance with the actual practice in respect of one or more categories, the matter should be referred to the Railway Board for decision.
- 4. The apprentices and trainees will draw the revised rates of Dearness Allowance appropriate to the revised rates of stipend.
- 5. The revised rates of stipend will take effect from 01.9.2008.
- 6. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
