Orders to facilitate Railway employees retired and in service to avail cashless treatment in medical emergencies at empanelled private hospitals around them on the basis of UMID card are still awaited from your good office.

We are happy to inform your office that an appropriate order vide letter number MD/ CMS/ misc/ 2023 dated 25.08.2023 referred at 3 above for cashless treatment to every Railway men in the Medical Emergency has been issued by the CMS/ NWR / Ajmer. The empanelled Hospitals will admit the patient and start required treatment in case of medical Emergency. Copy of orders (Hindi version) is enclosed for ready reference and record of your esteemed office.

All the empaneled private hospitals to be compelled for A Public Notice stated below need to be displayed at the Entry gate and at Reception of the hospitals for information to the beneficiaries.

"In case of an Emergency, Cashless treatment is available at this Hospital for Railway employee and retired employee having valid UMID card".

In no case the Railway personals should be forced to get a Referral letter from the Railway or/and pay Hospital Admission & treatment charges at the time of admission in the medical Emergency, the concerned hospital office should get
