EXPLANATORY NOTES:-

1. The table is based on the example of 2nd case of Annexure to DOP OM dated 12/5/2017 where pension has been arrived for a retiree of 4th CPC from S 19 (Level 11).
2. Row 1 gives the pay on retirement (LPD) in the SAG scale during 4th CPC.
3. The notional pay from 4th to 5th CPC (row 4) is fixed as per the Ready Reckoner for Fixation of pay in 5th CPC Scales.
4. The notional pay from 5th to 6th CPC (row 5) is fixed in accordance with the Fitment tables issued by MOF (DOE) dated 30.8.2008.
5. Notional pay in 7th CPC (row 6) has been fixed with a MF of 2.57 in the same way as for the working employees vide MOF (DOE) RESOLUTION dated 25.7.2016.
6. Row 9 gives pension as per option 1 for comparison purposes.
