NOTIFICATION REG. AMENDMENTS IN CLAUSE VI , VII , IX & XVII OF CONSTITUTION OF RSCWS

APPROVED IN THE GBM OF RSCWS HELD ON 07-02-2026

General Body RSCWS (Railway Senior Citizens Welfare Society), in its General Body Meeting, held on 7th February, 2026, approved the following Amended Clauses of the Constitution of RSCWS and resolved as under, as agreed upon in the ECM held on 20.04.2025, 08.06.2025 & 15.11.2025.

1 DATE OF EFFECT: The following amended Clauses in the Constitution of RSCWS shall be effective from the dates mentioned along with the ammendments.

2. AMENDED CLAUSE :

V) SUBSCRIPTION

- a) i) The subscription for the Members of the Society residing in Chandigarh, Mohali, Panchkula, Zirakpur or their out- skirts shall be Rs.500 per annum.
- a) ii) The subscription for those residing outside Chandigarh, Mohali, Panchkula, Zirakpur or their out-skirts, shall be Rs.200 per annum for a Member or Associate Member of the Society, including those who are from Department other than the Railways. "
- c) Life membership of the Society will be Rs. 4000/- for Life Members & Rs.2000/- for Out station Life Members & Associate Life Members.
- c) i) Additional Clause:-Spouse can become the Annual/Life member by paying 50% additional of the main member subscription as per above clauses.

NOTE:- The above approval of clause SI.No. V(a-i & ii), V(c) & c (i) will be effective from 01.04.2026


VII-c-Annual General Body will be held every year in April of the following year (after closing the Financial Year).

IX-a) Additional Clause:-i) Any new member joining RSCWS will be first introduced in writing by an existing member and then accepted by the President before he/she is inducted in RSCWS

IX-b) Correction :- The General Body shall elect the Central Executive Committee at its Biennial meeting which will consist of Office Bearers & CEC Members

IX- b) Additional Clauses:-

i) Validity of EC committee will be for **TWO years** with effect from approval date of GBM

NOTE:- The above approval of clause SI.No. VII(c), IX-a(i), IX-b, IX-b(i) will be with immediate effective from 07.02.2026

j) Secretary General will announce the election and nominate the Presiding officer prior to the completion of two years tenure as per the constitution and with the consultation of President and Chairman of the RSCWS. GBM will be called on the Election day















k) The Presiding officer will be nominated and will announce the schedule of the election i.e. date of nomination, date of withdrawal of nomination, date of election and date of counting etc. Where more than one nomination is received the election will be conducted in the presence of General Body by raising hands, otherwise member will be elected as unopposed.

l) On announcement of Election results, installation of new executive committee will take on the same day if tenure of Two years has been completed by the outgoing committee. Otherwise change of committee will take place on completion of their term of TWO years. Outgoing SG will detail the balance sheet for financial health, stock details, achievements and future planning etc to the new Incumbents and for the information of RSCWS members on the day new committee is taking charge.

XVII (iv) Additional Clause:-

ASSETS: In the event of expiry of terms of any office bearers, the assets issued to him shall be handed over/ transferred to the new incumbent immediately under proper procedure.

NOTE:- The above approval of clause SI.No. IX-b (j) to IX-b(l) & XVII (iv) will be effective from next election.
