Copy of Memorandum No. RSCWS/CHD/Memo -8th CPC/2023-6 Dated 30-05-2023 addressed to Smt. Nirmala Sitharaman, Hon'ble Minister of Finance, Government of India,

Sub: - Setting up of 8th Central Pay Commission (CPC).

- 1. Attention of Government drawn towards the financial constraints through which CG pensioners are passing due to defective formulae adoption by the previous Pay Commissions.
- 2. Per-capita income when interpolated with current price indices have double variation, moreover, hike in Dearness Relief does not provide the required relief.
- 3. Multiplication factor chosen by 7th CPC proved under scored when compared to the consumer price indices.
- 4. All future pay revisions under 8th CPC to be data driven in rationalized manner and delay to be compensated by Interim Relief. (Detail Memorandum is Available on web site: www.rscws.com)

Subject: <u>Hassle free treatment of Railway Beneficiaries</u>—especially old age Pensioners and their <u>dependents-Requestfo</u>r:

- i) Upgrading of Chandigarh Railway Health Unit to Sub Divisional Hospital:
- ii) Provision of Diagnostic, IPD and essential facilities like-X-Ray, Paramedical, Emergency, and Ambulance etc. in Health Unit/Hospital
- iii) Setting up of a lockup dispensary or Health Unit at Mohali.
- iv) Stream lining of system of Referral and approval of treatment in Emergency in Empaneled Hospitals.

Chandigarh Railway Station is going to be developed with world class facilities under the a eg is of NITI Aayog by IRSDC. We, the Railway Senior Citizens Welfare Society (RSCWS) being a registered pensioners association, want to bring the following few points to your notice for favorable consideration and necessary action thereon:

- That the condition of the present-day Railway Health Unit at Chandigarh is merely a basic dispensary class and it is primarily working as a medicine's distribution center with single doctor and limited staff without any Indoor and emergency treatment facility. In these circumstances the Railway Beneficiaries (Serving/Retired) are deprived of the quality treatment and always have to run for Divisional Hospital at Ambala Cantt. or go to local costly private hospitals which adds to their woes in case of acute emergency.
- 2. That at present more than 1500 Railway Beneficiaries plus the irfamily members totaling about 6000 are dependent on the Railway Health Unit Chandigarh. The number of Railway beneficiaries including employees, pensioners and their dependents, are bound to increase in the coming years with the extension of Chandigarh Railway Station and diversion of more trains through Chandigarh as well as origination of more trains from Chandigarh and Mohali. This makes it more imperative to upgrade the health care facilities for the Railway beneficiaries residing in and around Chandigarh and Mohali.
- 3. The HealthUnitislocatedacrosstheChandigarhstationyard,morethanakilometer away from there and is not covered by any public transport and so is not adequately accessible, particularly for the aged pensioners. And going by road, one has to govia Panchkula which adds another 4 Kms to reach there. Therefore, it is most necessary that the Health Unit/Sub-Divisional Hospital be preferably relocatedA on the front side of the Chandigarh Railway station for better accessibility.
- 4. Upgradation of Railway Health Unit Chandigarh to the level of Divisional/Sub-Divisional Hospital is urgently required with proper health care facilities. This will be of great help to Railway Beneficiaries for availing medical treatment at Chandigarh, Panchkula, Mohali and surrounding are as.
- 5. Railway Beneficiaries, including the Senior and Super Senior old age Patients residing at Chandigarh, Panchkula, Mohali and around are placed under serious hard ship as many times they are told to go to Ambala to get there ferral for the Empaneled Hospitals. This is totally unmindful of the ordeal the patients have to undergo to travel nearly 50 Kilometers to get the referral done. The Doctors at Ambala sometimes tell the Patients to go for treatment to Delhi (which is more than 200 Kms away) or to aprivate Hospital at Ambala, which is totally undesirable and problematic to get the treatment there, instead of being referred to an empaneled Hospital in and around Chandigarh, near their residence for cash less treatment at CGHS rates.

6. Settingupa Health Unitor Lockup Dispensary at Mohali station:

A number of railway retirees as well as working staff are now settling down in the fast-developing Mohali urban area. A number of trains to Punjab and Jammu side are also passing through Mohali. Taxing or driving down to Chandigarh Health Unit, about 20 Kms away on an average, is tough, tiring or even unsafe through the busy roads, for at least the aged retirees. So, in all earnestness, a lock up dispensary/Health Unit beset up at Mohali immediately. This will also be more suitable for Chandigarh residents of southern sectors.

- 7. It is, there fore, requested that:
 - i) Railway Health Unit at Chandigarh be suitably upgraded to the level of Divisional/Sub-Divisional Hospital.
 - ii) An emergency IPD Ward and another senior Doctor and essential facilities like X-Ray, Paramedical, Diagnostic, Emergency, and Ambulance facility etc. be provided at Chandigarh Health Unit/Hospital.
 - iii) Authorizing the Medical Officer in-chargeofthe Health Unit Chandigarh:
 - a) To Refer Patients for treatment to Empaneled private Hospitals as per choice of the Patients or near to their residence; And
 - b) Directly approving Emergency Treatment in Empaneled private Hospitals. At present approval has to be obtained from CMS office, Ambala.
 - iv) A lock up dispensary or Health Unit be setup at Mohali.
 - v) Hassle free treatment of Railway Beneficiaries especially of the old age Pensioners and their dependents may please be provided with a patient friendly approach by all concerned.

Subject: <u>Grant of Ex-Gratia Payment to CPF (Contributory Provident Fund) Retirees who retired after 31-12-1985 – Appeal for removal of discrimination between CPF Retirees who retired up to 31-12-1985 & after 31-12-1985</u>

Reference: DOP & PW OM No. 45/52/97-P&PW Dated: 16-12-1997.

- 1. We invite your kind attention and seek early justice for the CPF Retirees who retired after 31-12-1985 and are suffering great hardship due to non-receipt of the Ex-gratia Payment as paid to those CPF Retirees who retired up to 31-12-1985.
- 2. Ex-Gratia Payment of Rs.600/- PM plus DR was granted, to CPF Optees who retired between 1-4-1957 to 31-12-1985 vide DOP&PW orders cited above. The amount of Ex-gratia Payment and DR thereon were revised from time to time. But no Ex-Gratia Payment has been granted to the CPF Optees who retired after 31-12-1985. This is unjust, discriminatory and causing continuous hardship to the post 31-12-1985 CPF Retirees.
- 3. All CPF Retirees were recruited before 1-4-1957 and as such formed one class of employees. Any distinction between them on the basis of date of Retirement is discriminatory and violative of Articles 14, 16 and 39 of the Constitution of India as well as according to the Law of Justice settled in DS Nakra's case and General Bains' Case decided by the Apex Court of India.
- 4. The number of surviving CPF Optees, who retired after 31-12-1985, is very small as all the CPF Optees joined service before 1-4-1957 and the last ones of such optees would have retired by 1997 or before that. As such, the financial implication of granting them Ex-Gratia payment would also be small but would do the much-delayed justice to them and provide them the much-needed relief.
- 5. It is, therefore, requested that the CPF Optees who retired after 31-12-1985 and their Families be granted Ex-Gratia Payment & DR at par with the CPF Optees who retired up to 31-12-1985 and unjust discrimination and hardship may please be removed.

Sub: - Medical Treatment to Railway Beneficiaries - Grievance regarding Violations of Railway Board and PCMD/ N Rly HQ orders by Ambala Division Medical Deptt. in referral of cases, for specialized treatment in empaneled hospitals

Reference: i) Railway Board's letter No. 2005/H/6-4/Policy-II Dated 30.07.2018. (Copy attached)

ii) PCMD Orders authorizing ADMO HU Chandigarh a) to refer Railway patients to empaneled hospitals with telephonic approval of CMS UMB & b) to approve treatment in emergency in the private empaneled hospitals, with telephonic approval of CMS UMB within 24 hours.

<u>Preamble:</u> Railway Senior Citizens Welfare Society (RSCWS) is the Identified Organization Under the Pensioners Portal and is Recognized by the Government of India as a Member of SCOVA (Standing Committee of Voluntary Agencies - GOI) for representing the grievances of the Pensioners.

- 1. We are constrained to bring to your kind notice the Stark VIOLATIONS and utter INDIFFERENCE, being adopted of late by the medical department of Ambala Division, in not referring the Railway Beneficiaries residing in Chandigarh tri-city and surrounding areas, for getting specialized medical treatment from the recognized private empaneled hospitals, thus endangering their Health Care, particularly of the aged pensioners:
 - i) That the Railway Beneficiaries residing in the tri-city of Chandigarh, Panchkula & Mohali and in the surrounding areas, especially the elderly patients requiring specialized medical treatment, are facing a lot of difficulties in getting requisite treatment due to REFUSAL by the Railway Doctors at the NR Health Unit Chandigarh as well as at the Divisional Hospital, Ambala, to refer the patients to the empaneled private hospitals as per laid down procedure.
 - ii) a). Examples of some recent related cases are enclosed at Annexure I.
 - Some other cases have also happened in the recent past wherein Railway Beneficiaries, including elderly patients residing in and around Chandigarh, have been referred to the empaneled hospitals at Ambala instead of the empaneled hospitals in and around Chandigarh. This is totally unjust and amounts to sheer harassment of the sickly and the elderly aged for whom extra special attention & care is guaranteed right up to the PMO, New Delhi.
 - c) Insistence by the Doctors to refer patients of Chandigarh to Central Hospital New Delhi and travelling all the way to Delhi, straightaway amounts to the aged patients undergoing torture.
 - d) Referring Patients to the overcrowded PGI is equally unjustified as PGI charges the CGHS rates at par with the empaneled hospital and the patients have to pay in cash at the PGI instead of the cashless system in the empaneled hospitals.
 - e) Para 2.1 of Railway Board's orders dated 30-7-2018, (cited above), clearly provides that "the Railway Doctor should take all necessary steps to address the medical need of the Beneficiaries with a sympathetic and helping attitude.
 - f) The main objective should be the convenience of the Patient and the distance to be travelled to reach out to the medical facility for the requisite treatment.
 - g) As such an immediate corrective action needs to be taken and all concerned be advised.
 - h) Doctor at the Health Unit Chandigarh, be authorized to refer the patients to the empaneled private hospitals, as per choice of the patient, after taking the telephonic or Online approval thereof from the CMS Ambala, as per already laid down procedure by the PCMD/NDLS.

Sub: -Regarding Extension of Pan India Cashless Treatment facilities to Railway Beneficiaries at AllMs & PGIs – (at par with other Central Government employees & Pensioners/ CGHS Beneficiaries).

- Ref: -1. Govt. of India, Ministry of Health & Family Welfare, Department of Health & Family Welfare, Directorate General of CGHS letter F No. Z16025/12/2023/CGHS-111 Dated 31-05-2023.
 - 2. Press Release by MoH&FW dated 27-06-2023 Regarding MOA between AllMS-New Delhi, PGIMER-Chandigarh & JIPMER-Puducherry

In reference to the above letters, facility of Cashless Treatment has been extended to CGHS Beneficiaries in the Medical Institutes of National Importance(AlIMS at New Delhi, Bhopal, Bhuaneswar, Patna, Jodhpur, Raipur, Rishikesh, PGIMER-Chandigarh & JIPMER-Puducherry)with the following salient features:

- 1. Cashless treatment will be available in outpatient departments (OPD), investigations, and indoor treatment for CGHS pensioners and other eligible categories of beneficiaries.
- 2. These institutes will raise credit bills for CGHS pensioners and other eligible beneficiaries, and CGHS will preferably make payment within 30 days of receiving the bills.
- 3. CGHS beneficiaries will be admitted only upon the production of a valid CGHS Beneficiary ID Card for treatment at these institutions.
- 4. Separate Help Desks and accounting systems will be created for CGHS beneficiaries at AIIMS New Delhi, PGIMER Chandigarh, and JIPMER Puducherry.
- 5. Medicines prescribed by the doctors at these institutions, whether for OPD treatment or at the time of discharge, will be collected by beneficiaries through CGHS
- 6. CGHS beneficiaries will no longer require referrals to access healthcare facilities at these institutions.

Railways, also being a central government pan India organization, the Railway Board is requested to extend these facilities of Cashless Treatment in all AIIMS and PGI Chandigarh etc. without referral from the Railway Hospital to Railway beneficiaries also at par with CGHS Beneficiaries which will enable them to avail state-of-theart medical facilities and also reduce the referrals burden on CMSs of Railway hospitals

Central Pension Accounting Office (CPAO) has been receiving grievances regarding non acceptance of Life Certificate by Pension Disbursing Banks on issuance of the same by another authorized bank. In this regard, attention is invited to Para 14.2, Para 14.3 and Para 16.3 (of Para 16- Payment of Pension to N.R.I. Pensioners) of "Scheme for Payment of Pensions to Central Government Civil Pensioners by Authorized

- 1. Banks" issued by this office. In terms of codal provisions mentioned above, the life certificate in respect of NRI Pensioners/Family Pensioners issued by an officer of an Indian Authorized Bank attached to its branch in the country (outside India) where the pensioner is residing may be accepted by the CPPCs.
- 2. In view of above, all the CPPCs of authorized banks are requested to strictly follow above mentioned guidelines and accept the life certificate in respect of NRI Pensioners/Family Pensioners signed by the officer of an Indian authorized bank's Foreign Branch (authorized by CPAO for Pension Disbursement) after due verification of Life Certificate issuing authority for smooth disbursement of pension/family pension. This issues with the approval of the Chief Controller (Pensions). Govt. of India, Min. of Health & Family Welfare, Department of Health & Family Welfare DirectorateGeneral of CGHS F No. Z 16025/12/2023/CGHS-111 Dated 31st May, 2023 Subject: Treatment of CGHS pensioner beneficiaries and others at All India Institute of

With reference to the above subject the undersigned is directed to state that All India Institute of Medical

- d) CGHS Desk at AIIMS refers the beneficiaries to OPD/Investigations / Indoor treatment as the case may be.
- e) Bills in physical form along with copy of CGHS card shall be submitted by AlIMS in the last week of month to the office of Addl. Director. CGHS of concerned City.
- f) AIIMS shall send bill to CGHS as per AIIMS rates, except in case of Room rent for Indoor treatment. Bills for room rent shall be sent to CGHS as per CGHS rates for CGHS empaneled Hospitals. The beneficiaries are eligible for indoor treatment as per their ward entitlement in CGHS empaneled HCOs, as indicated on their CGHS Card.
- g) AlIMS shall create a separate Bank Account for CGHS beneficiaries to reimburse the bills by CGHS.
- h) Additional Director, CGHS of concerned City shall process the bills expeditiously and payment shall be credited into the Bank Account created by AIIMS for CGHS.
- i) No preferential treatment shall be provided to CGHS beneficiaries.
- j) AllMS shall provide implants available at the Institute and the beneficiaries shall not have option to choose Specific Implants of their choice.
- ${f k)}$ Medicines prescribed by AlIMS's doctors for OPD treatment or at the time of discharge from AlIMS will be collected by the beneficiaries through CGHS.
- CGHS pensioners and others eligible for cashless treatment can avail treatment without any mandatory referral from CGHS.
- m) Additional Directors, CGHS of Bhopal, Bhubaneswar, Nagpur, Patna, Dehradun and Jaipur shall contact All India Institute of Medical Sciences, Bhopal, Bhubaneswar, Raipur, Patna, Rishikesh and Jodhpur respectively for the seamless implementation of this initiative.

On the receipt of the physical booklet and related documents, the CPPCs would verify the details and if any difference is found between the e-PPO and manual PPO, the same should be intimated to CC(P), CPAO within a month for necessary corrective action. It is observed that the banks are not following the CPAO's 0M dated 12.07.2021 which is causing hardship to the pensioners/family pensioners. It is once again directed to diligently follow CPAO's instructions and credit the first pension on the receipt of the e-PPO. This issues with the approval of the Chief Controller (Pensions).

Sub: <u>Grant of Dearness Relief to Central Government pensioners/family pensioners — Revised rates</u> effective from 01.01.2023.

The undersigned is directed to refer to this Department's 0M No. 42/07/2022P&PW(D) dated 08.10.2022 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 38% to 42% of the basic pension/family pension (including additional pension/family pension) w.e.f 01.01.2023.

- 2. These rates of DR will be applicable to the following categories: -

 - (iii) All India Service Pensioners/Family Pensioners.
 - (iv) Railway Pensioners/Family Pensioners.
 - (v) Pensioners who are in receipt of provisional pension.
 - (vi) The Burma Civilian Pensioners/Family Pensioners and Pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's 0M No. 23/3/2008-P&PW(B) dated 11.09.2017.
- 3. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 4. The offices of Accountant General and authorized Pension Disbursing Banks are requested to arrange payment of Dearness Relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, 11/3480-11 dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalized Banks.

Subject: Validity of CGHS Card in all CGHS Centers

The undersigned is directed to draw attention to the Order No Misc. 6024/2007/CGHS(HQ)/CGHS(P) dated the 17th December 2012 and to reiterate that CGHS Card is valid at any CGHS Wellness Centre in the Country for availing CGHS benefits as per the details given under:

CGHS Card is valid in any Wellness Centre in India and no additional document / attachment is required.

Medicines shall be issued for up to '3' months, in case of beneficiaries undergoing treatment for chronic illnesses. Referral / endorsement for treatment from private HCOs empanelled under CGHS shall be issued from any CGHS wellness centre.

Retired Freedom Fighter of 102 years Gets Arrears of Pension After the Intervention of Karnataka High Court.

The Karnataka High Court on 20th February, in H. Nagabhushana Rao V. The Under Secretary FFR Division & Others (WRIT PETITION No.405 OF 2023) held that <u>Pension is a trite, not a bounty and no elderly at this age should be bound to produce his life certificate before the bank rather the bank should go and obtain it.</u> The judgement was presided by Honourable Justice M. Nagaprasanna.

FACTS OF THE CASE:

The writ petition is filed under Article 226 of the constitution of India praying to direct the R1 to pay Rs. 3,71,280/- along with the interest to the petitioner. The petitioner, who is now 102 years old, was a recipient of Swatantra Sainik Samman Gaurava Dhana pension being a freedom fighter from 1974 from Government of India. This pension was granted to the petitioner by both the Central and the State Governments respectively. The pension of the petitioner was abruptly disrupted and when enquired, it was implied to the petitioner that he had not submitted his Life Certificate for the year 2017-2018 and later he submitted the Life Certificate on 24-12-2018. The Government issued sanction letter belatedly releasing pension for the period from 24-12-2018 to 05-10-2020. However, the arrears of pension between 01-11-2017 to 24-12-2018 were not paid, which amounted to `3,71,280/-. So, the petitioner knocked at the doors of the court.

JUDGEMENT:

The Court held that the petitioner would be entitled to all the arrears along with interest, as the Bank has failed to collect Life Certificate from the petitioner. The Bank should have visited the petitioner and collected the Life Certificate and regulated pension A caveat, in some cases of the Bank is obliged to do so. In cases, where the pensioners face genuine problems, it is the obligation of the Bank officers to visit those persons and take Life Certificate and update them. The pensioners could be septuagenarians, octogenarians, nonagenarians or centenarians like the petitioner. Therefore, this order cannot be construed to be sweeping direction in all cases where the Life Certificate has to be obtained by the Bank officers, the Bank officers ought to perform their duty in terms of the guidelines so as to avoid unnecessary litigation of the kind that has been generated not once, twice, but three times under clause 2.4. The court opined that the raison d'etre for grant of pension is the inability to provide for oneself due to such old age. This can only be withheld, curtailed or taken away, only in accordance with law.

Justice M. Nagaprasanna said <u>"Ebbing mental prowess and physical incapacity due to age was one of the prime reasons why the certificate could not be submitted in time. This, in the peculiar facts of this case, by no stretch of imagination, can be construed to take away the right of the petitioner for grant of pension, particularly, in the teeth of the guidelines."</u>


- Opening Address by Sh. T.S. Kalra, Chairman/RSCWS:

- The growth of RSCWS is a success story as people across the country appreciate our efforts and endeavor, we are relentlessly chasing the issue of additional quantum of pension after every five years after 65 years of age by 5, 10 & 15 percent with concerned ministries and departments. The issue of annual increment or additional quantum of pension ischased by theRSCWS since the 5th CPC and now we hope if the finance ministry gives its concurrence, then there will be good news for all of us.
 - Out of one thousand pensioner's associations, RSCWS is having affiliation with SCOVA which is another achievement.
 - The issue of raising of FMA from Rs 1000/- per month to Rs. 3000/- per month is also being rigorously chased with concerned authorities by RSCWS and is appreciated by the retirees across the country. We are hoping an early notification by Rly. Board in this

regard.

- ❖ We are representing the concerned ministry with facts and figures to restore the Commuted Pension after 12 years instead of 15 years as interest on Small Saving Schemes have been slashed by the Government during last five years by 68%.
- ❖ Despite the callous attitude of Railway Medical Authorities towards the demands of empaneled Hospitals, the empaneled Hospital are still providing health care facilities to the RSCWS members at CGHS rates it is a great achievement of the society.
- RSCWS is chasing the matter with concerned authorities for empanelment of a few more Pvt. Hospitals of Panchkula with Railways.
- ❖ The matter of Upgradation of Railway Health Unit at Chandigarh to Sub-Divisional Hospital is brought into the notice of Chairman Railway Board with more facilities and doctors.
- Pensioners are again suffering on account of not directly referring them to empaneled Hospital by ADMO/CDG which is violation of Policy Guidelines issued vide Rly. Bd's letter of 30.07.2018. This issue is also taken up with CMS/UMB for streamlining the referral procedure by seeking telephonic approval by ADMO/CDG.
- ❖ To scale the new heights, we require more and more enrollment of new members of RSCWS this is to be taken up seriously.
- This is for the information of you all that as per the latest guidelines issued by the Rly. Board now we cannot board a train by simply carrying the Complimentary Pass in our pocket, instead we have to get a Ticket from the reservation counter otherwise you will be treated as without ticket event if you are having a valid Privilege or Complimentary Pass.
