Reference - No. 2024-4/RSCWS/CHD/Memo-DGRHS/Dated:-06.05.2024

In reference to above, the above mentioned all private hospitals empanelled with Ambala Division are here by given following instructions to implement with immediate effect-

1). As per Clause 4, of MOU signed between above mentioned hospitals & CMS/UMB "In emergency the hospital will not refuse admission or demand an advance payment from the Railway beneficiary or his family members and will provide credit facilities to the patient whether the patient is a serving employee of railway or a pensioner availing facilities, on production of a valid Railway Medical Identity Card (UMID)."

In this situation hospital will intimate through Email to Northern Railway Divisional Hospital Ambala Cantt with in 24 hours of admission & will seek on line approval for treatment. The Railway Authorities will give on line approval if agrees with the emergency condition of the patient.

The Empanelled Hospital will put up a display board near entry gate and clearly mentioned that this
hospital is empanelled with Ambala Division Northern Railway and on production of valid UMID Card cashless
emergency treatment will be given to all railway beneficiaries.

Please comply all the above mentioned instructions so that unpleasant situation can be avoided.

# "STAY SAFE DURING RAIN"

- 1. STAY AWAY FROM ELECTRICAL INSTALATIONS, such as poles, transformers and substations during rain.
- 2. Use SURGE PROTECTORS to safeguard electrical home appliances from lightening surge.
- 3. DO NOT LEAVE open plug sockets or connected extension boards unattended.
- 4. INSTALL AN EARTH LEAKAGE CIRCUIT- BREAKER (ELCB 35mA) AS ELECTRICAL SAFETY Devise at main distribution board with MCBs of adequate current capacity and type for each circuit to avoid shocks, overload tripping & short circuiting etc.
- 5. ALWAYS KEEP A "TESTER" AT HOME. do not touch any open/broken wire without ensuring electric current by an electric "tester" if found live, switch off mains & call your electrician.
- 6. MAINS SWITCH should be switched off if INGRESS OF WATER is observed in meter cabin.
- 7. DON'T ALLOW CHILDREN TO PLAY OR SWIM IN FLOODED AREA'S.
- 8. CAUTION CHILDREN for NOT TO PLAY near electricity installations, even if it is barricaded.
- 9. Avoid PLAYING IN PARKS when THOSE ARE WATERLOGGED.
- 10. UNPLUG YOUR ELECTRONIC GADGETS like TV, Computer etc in case of heavy thundering.
- 11. DRIVE SLOWLY IN RAIN as brake pads go wet and brakes fail to stop your vehicle.

# Brief of Government/Railway Board Orders Concerning Pensioners and RSCWS representation for Betterment of Pensioner

- ❖ F. No. 1012/26/2023-Ad./VA, Government of India, Ministry of Finance, Department of Revenue Central Board of Indirect Taxes & Customs Dated 01-12-2023
  - Sub: Clarification on the effect of pension cut on the amount of family pension in case of death of retired government servant during the currency period
  - 1. Kindly refer to Rule 50(2) of ccs (Pension) Rules 2021 governing the amount of family pension payable to the family of deceased government servants. In this regard, doubts have been expressed on whether the penalty of pension cut would affect the quantum of family pension in case of death of retired government servant during the currency of the Penalty.
  - 2. In this connection, the nodal department. i.e., the Department of Pensions and pensioners, welfare has clarified that the penalty of pension cut imposed on a government servant under Rule 8 of CCS (Pension) Rules, 2021 is not applicable for payment of family pension. The family pension has to be paid at a uniform rate of 30% of the last basic pay, subject to a minimum of Rs 9000/- per month. However, in case the family pensioner is entitled to enhanced family pension; the amount of family pension will not exceed the pension authorized on retirement from government service.
  - 3. All the offices under CBIC are hence directed to bring this to the notice of all the officers dealing with pension matters for strict compliance.
- Ministry of Finance GOI, Department of Expenditure F. No. CPAO/Co-Ord/B-DN/Misc.(03)/2023-24 Dated 20/28-02-2024
  - Sub: issuance of Pension Slip by Pension Disbursing Banks on monthly basis,
  - Ref:- DP&PW's O.M. No. 1(4)/2021-P&PW(H)-7223 Dated 22nd June, 2021 and O/o CGA's O.M. No. TA-3-61112020-TA-III-Part(I)/es-2184/57 dated 19th January, 2024

Vide which CPPCs have been instructed to invariably issue pension slip to the pensioners after credit of pension on their registered Mobile Number through SMS/WhatsApp and e-mail. Pensioners to ensure that Pension pay slip is received by them else contact your bank to update your contact Number.

- Memorandum No. 140-Med/Empanelled Hospital/UMB/23 Dated 14-12-2023 of CMS/NRDH/UMB
  - Sub: Provision of cashless OPD consultation & related investigation for RELHS beneficiaries aged 75 years & above from specialists of Private Hospitals empanelled by Railway- As a Pilot Project for One Year From 01-11-2023 to 31-10-2024.

In reference to above all empanelled hospitals are advised to make necessary provisions to provide facilities on cashless basis at CGHS rates to Railway beneficiaries aged more than 75 years as mentioned in attached letters. This facility is available for only those aged 75 years & above and RELHS beneficiaries can avail this facility if they are eligible for OPD consultation at Railway Hospitals/Health Units. This facility is not available to beneficiaries having UMID card with FMA.

Private Hospitals shall submit the bills to the Railways for payment along with copy of UMID card, copy of prescription/Reports and declaration form signed by the beneficiaries and duly endorsed by the competent authority of the empanelled hospitals.

Railway beneficiary availing this facility need to submit a Declaration form with details of patient at Railway Empaneled Hospital.

- P&PW GOI office memorandum No. 28/03/2024-P&PW (B)/Gratuity/9559 dated 30.05.2024
  - Sub: Enhancement of Maximum limit of Gratuity to Central Government employees on reaching the Dearness Allowance rate to 50% (Implementation of recommendations of the Seventh CPC)

On enhancement of DA rates from 46% to 50% of the basic Pay with effect from 1<sup>st</sup> January 2024 vide OM No. 1/1/2024-E-II(B) dated 12.03.2024, payment of Gratuity under National Pension System Rule 2021 would be increased by 25% i.e. from Rs. 20.00 Lakh to Rs. 25 Lakh with effect from 1<sup>st</sup> January 2024.

Formal Amendment to the CCS (Pension) Rules, 2021 and the CCS (Payment of Gratuity under under NPS) Rules, 2021 will be notified separately.

**Abstract from Medical Seminars conducted for RSCWS and Health tips on the subjects:** 

1. <u>"Spine injuries and preventive measures" by Dr. Shiva Kumar Bali (Spine Surgeon), an expert of technological advances in spine surgery at Shalby Hospital.</u>

Dr Bali discussed inside details of Spine and gave tips for taking care of spine 24x7 through doing controlled exercises and Yoga on regular basis, sitting in right posture. He advised to remain in your

physical limits while working, sitting, lifting shifting loads, running, walking and doing workout. Never ever push yourself beyond your capacity without professional guidance and protection.

He suggested every male above 60 years of age and females after menopause to get Bone Mineral Density (BMD) test as routine check-ups for timely detection of osteoporosis. On detection of osteoporosis, one should start with hormonal replacement (teriparatide) for period of 2 years to prevent life threatening spine and hip fractures. Frequency of bone scan during follow-up may be once in two years till your T score is normal (+2.5 to -2.5).

For any pain in leg, back, neck and hands avoid self-medication take rest for day or two. Visit to a Doctor if pains are not reduced. Any abnormality/sudden pain/ disorder in functions while resting/ sleeping/ awaking/ walking, talking, eating, dysfunctions in passing urine and constipation must be consulted with specialist to get due medication as preventive measures. Otherwise one may land into bigger problem with the spine which may become permanent disability.

## 2. <u>Dementia by ' Dr.Sachin Bindal minimally invasive surgery expert Neurosurgeon at</u> Shalby Hospital Mohali

Dr.Sachin Bindal expert Neurosurgeon trained from prestigious institute PGI Chandigarh, discussed about preventing Dementia. He said with increasing life expectancy Dementia is becoming one of the biggest challenging disease crippling life of people and their family members. Dementia not only makes sufferers life miserable but also makes family members life pitiable.

He pressed upon early diagnosis and treatment as the only option in preventing this morbid brain problem. He explained that our Brain is the CPU of our body and it controls all the functions of our body. As CPU is important for proper functioning of a computer, proper functioning of our brain is important for us to live independent and happy life. But It's important to note that unlike a computer any damage to the brain is permanent and once deterioration occurs beyond certain level it is not possible achieve any repair/recovery/regeneration. He mentioned that, just like Heart any damage to Brain of Human body is irrecoverable. Any loss/damage occurred will be permanent for rest of life. Therefore timely prevention is the only option.

Dr. Bindal discussed about early warning symptoms of this brain problem and advised to immediate consult your doctor to take you on a few medications after some tests so that further damage/decay is stopped.

These basic warning symptoms at initial stage are forgetting names / places/ events of your recent activities. Just like once a hard disc is full, you cannot save new record unless overwriting by erasing old data, this symptom in human brain lead to problem called "Dementia", when u find difficulty remembering new thing though u may remember all ur old memories quite well.

Most important early sign is not able to recollect the name of known faces and unable to recollect location of kept items at home.

If these signs are noticed in you it's advisable to consult us as early as possible to prevent further deterioration.

Dr.Bindal advised general ways for preventing early onset dementia these days. Most important is to remain calm, control your unnecessary involvement on petty issues and take good balanced diet. Take adequate rest for better health of your Brain. Train your body for keeping calm in difficult situations.

Take away Message from medical seminar is "Timely Prevention and Treatment is the only option".
