Memorandums Submitted by RSCWS to Various Departments & Ministries

1. Memorandum No. RSCWS/CHD/DRM/Office Accom/2025-20 Dated: 02.11.2025 addressed to Divisional Railway Manager, Ambala Cantt.

Sub: Provision of Office Accommodation for RSCWS at Chandigarh/Mohali

Brief: - Briefly speaking, this society was established in 1991. It is Identified & recognized by the Department of Pension & Pensioners' Welfare (DOP&PW), Government of India, (since 2014-15), under the Pensioners' Portal. It is registered under Registration of Societies Act vide registration no. 1881 and is getting an annual grant under the Pensioners Portal from the Deptt. Of Pension & Pensioners welfare, Govt. of India.

With the increasing number of retired individuals, the Society faces difficulties due to nonexistence of proper office accommodation for day-to-day office work. For the effective functioning of the society, separate office space is very much required at suitable Railway premises for day-to-day office work and for easy access to Railway pensioners and their families residing in and around Chandigarh, Panchkula & Mohali and nearby areas. DRM/NR, Ambala is requested to please consider the matter urgently & sympathetically to allot accommodation of one larger Room (for Office & Meetings) with an attached toilet and a small Store Room for keeping files & Office records.

2. Memorandum No. RSCWS/CHD/FM//2025-22 Dated: 11-11-2025 addressed to The Hon'ble Finance Minister of India Ministry of Finance, Government of India North Block, New Delhi.

Subject: Inclusion of Pensioners for Extension of Benefits under the 8th Central Pay Commission (CPC) in view of Gazette Notification.

Brief: - This memorandum is submitted for your kind consideration regarding the extension of benefits of the 8th Central Pay Commission (CPC) to Central Government pensioners and family pensioners, in accordance with the principles of parity and justice as enshrined in previous CPC recommendations and government notifications.

3. Memorandum No. RSCWS/CHD/Health/2025-23 Dated: 19-11-2025 addressed to The Secretary, Ministry of Health and Family Welfare, Government of India, Nirman Bhawan, New Delhi.

Subject: Request to incorporate a clause in the Accreditation Schedule of NABH to provide CGHS rates to retired Railway pensioners holding valid UMID (Unique Medical Identification) or Retirement identity cards.

Brief: - RSCWS wishes to draw your kind attention to an important issue concerning healthcare accessibility and affordability for retired railway pensioners.

Presently, hospitals accredited under the National Accreditation Board for Hospitals & Healthcare Providers (NABH) cater to beneficiaries under various government health schemes, including the Central Government Health Scheme (CGHS), the Defense (ECHS) and the Railway Health Services. However, a large number of retired railway pensioners, despite holding valid Unique Medical Identity (UMID) cards, face difficulties in availing treatment at CGHS rates in these accredited hospitals.

4. Memorandum No. RSCWS/CHD/PRCP/2025-24 Dated: 19-11-2025 addressed to The Chairman and Managing Director, Indian Railway Catering and Tourism Corporation (IRCTC) 4th Floor, Tower- D, World Trade Centre, Nauroji Nagar New Delhi.

Subject: Request for necessary changes in the IRCTC online reservation system to enable e-ticket booking for companions on post-retirement complimentary e-passes for retirees aged 70 and above, drawn online via the HRMS module.

Brief: - The Railway Senior Citizens Welfare Society (RSCWS) represents the interests and welfare of a large number of retired Indian Railway employees. We wish to bring to your kind attention a critical difficulty faced by our senior members, particularly those aged 70 years and above, while utilizing their entitled post-retirement complimentary e-passes through the IRCTC online reservation system.

Reply Received From MD, IRCTC: - Please be informed that the facility of booking online ticket for a companion at the applicable concessional fare is available on IRCTC's NgeT platform, only if the user has opted for the Companion Booking Facility at the time of applying for the Pass. Following is the procedure: -

Step1: (i) After login on IRCTC website enter your journey details and select "Railway Pass Concession" on book ticket page. (ii) Confirmation po-up is displayed "you are booking ticket on "RPC. Do you want to continue?". Click OK. (iii) Click on "search" Button to continue.

Step2: (i) Train list page is displayed. (ii) Select train from the list, select desired class of travel and click on "Book Now" button.

Step3: (i) Passenger input page is displayed. (ii) Enter main pass holder details and click on add passenger icon to add another passenger as Companion. (iii) Enter name, age, gender of the passenger to be booked as companion and select concession type as Pass Booking. Pass UPN number and Pass PIN for companion will be entered as same as main pass holder. The non-dependent passenger details will be treated as companion if matching to the HRMS module. (iv) Click to "Continue" to submit passenger details. (v) On submitting passenger details, the entered details are validated with HRMS and pop-up "Yes/No". (vi) Verify entered pass Companion click "Yes" option to confirm.

Step4: (i) Booking review page is displayed. (ii) Fare to be paid as calculated and received from PRS is displayed under the fare summary. (iii) Review you passenger details and fare summary. (iv) Fill "Captcha" and click to "Continue" button.

Step5: (i) User is directed to Payment Gateway if any fare is to be paid. (ii) Request is sent to PRS for booking e-ticket. (iii) On successful response from PRS the ticket booking confirmation page showing the passenger along with companion is displayed.

5. Memorandum No. RSCWS/CHD/Med/2025-27 Dated: 14-12-2025-27 addressed to The Principal Chief Medical Director, Northern Railway, Baroda House, New Delhi.

Subject: *Provision of Cashless Medical Treatment Facilities for Railway Pensioners Residing in the Tri-City (Chandigarh–Mohali–Panchkula) at PGIMER/CHD, GMCH-32/CHD, GMSH-16/CHD, Govt. Hospital Sector-6 Panchkula & Other Government Hospitals in the adjoining areas.*

Brief: - RSCWS highlight the urgent and long-pending requirement for extending cashless medical treatment facilities to Railway pensioners and their dependents residing in the Tri-City region of Chandigarh, Mohali, and Panchkula and adjoining areas.

Due to the absence of cashless facilities, elderly pensioners are forced to: Travel long distances to Northern Railway health units or empanelled hospitals outside the Tri-City, Face financial strain during emergency or life-threatening medical situations, Bear out-of-pocket expenditure and prolonged reimbursement delays. Given their age and health conditions, this situation is extremely distressing and needs immediate resolution.

6. Memorandum No. RSCWS/CHD/Med/2025-28 Dated: 22-12-2025-27 addressed to The General Manager (Medical) Northern Railway New Delhi.

Subject: *Empanelment of More Private Hospitals in Tri-City Chandigarh and Tie-Up with Major Government Hospitals with Recognition of UMID Card on CGHS Rates for RELHS Beneficiaries.*

Brief: - It is observed with concern that the number of empaneled private hospitals under RELHS in the Tri-City area is very limited. This causes serious hardship to elderly pensioners, many of whom suffer from chronic and age-related ailments requiring specialized and emergency medical care.

Prestigious government institutions such as PGIMER, Chandigarh; Government Medical College & Hospital (GMCH), Sector 32, Govt. Multi-Specialty Hospital (GMSH), Sector 16; and Homi Bhabha Cancer Hospital, are already providing treatment on CGHS rates and are extending cashless treatment facilities to CGHS and ECHS beneficiaries. However, RELHS beneficiaries possessing valid UMID cards are not being uniformly extended similar benefits, which amounts to unwarranted discrimination against Railway pensioners.

7. Memorandum No. RSCWS/CHD/Med/2025-29 Dated: 22-12-2025-27 addressed to The Principal Medical Director, Northern Railway HQ Office, Baroda House, New Delhi.

Subject: *Unnecessary harassment to Railway retirees of Tricity area, due to referral to Divisional Hospital, Ambala Cantt for cataract surgery and non-empanelment of eye care hospitals in Tricity area.*

Brief: - Serious inconvenience and hardship being faced by Railway retirees residing in the Tricity area (Chandigarh–Panchkula–Mohali) due to the recently introduced system, by CMS/Ambala, of referring them to Divisional Hospital, Ambala Cantt for cataract surgery and other eyes treatment.

Empanelment of Drishti Eye Hospital, Panchkula may be extended on an interim basis and furthermore other suitable eye care hospitals should be got empaneled in the Tricity area.

Reply Received from CMS & ADRM/UMB: -

1. Empanelment of Sohana Hospital/Mohali is under process.
2. Empanelment of Drishti Eye Hospital/Panchkula is also under process.
3. Referral of routine cases is being done as per Railway Board policy. Routine cases are to be managed in railway hospitals (Divisional/Central hospitals)

(Note: RSCWS is not satisfied with reply and we are forwarding another memorandum in this continuation, stressing for more & more empanelment of private hospitals with special stress on no referral for pensioners aged 70 years and above.)

LATEST GOVERNMENT ORDERS CONCERNING PENSIONERS

1 Government of India, Ministry of Railways, Railway Board, letter No.2024/TG-1/20/P/Reservation Chart Dated 18-11-2025 addressed to Principal Chief Commercial Managers, All Zonal Railways.

Sub: - Automatic Preparation of first reservation charts.

Please refer to this office letter of even dated 02-07-2025 (CC No. 10 of 2025) advising there in the timings for preparation of first reservation charts.

With view to streamline the procedure of preparation of reservation charts, it has been decided as under: -
If first reservation charts are not prepared at least 8 hours before the scheduled departure of the train by the Zonal Railways, the system will automatically finalised the first reservation charts 8 hours before the scheduled departure of the train. However, for trains departing between 05:00 & 14:00 hours automatic charts shall be prepared as instructed in the CC No. 10 of 2025.

- a) However, for exceptional circumstances, Zonal Railways will have powers to prepare reservation charts short of 8 hours.
- b) There shall be no change in the timings of preparation of second reservation charts.
- c) Reservation Charts at remote locations should be automated as per the above guidelines.
- d) CRIS will make necessary modifications in the software under intimation to all Zonal Railways as well as this office.

Government of India, Ministry of Finance, Department of Expenditure, OM No. CPAO/Co-Ord/B-CDN/Misc.(03)/2025-26/11E-181 Dated 25-11-2025 addressed to all Pension Disbursing Authorities.

Sub: - Providing Pension Payment Slip to all Central Civil Pensioners/Family Pensioners on monthly basis.

Reference is invited to this office OM NO. CPAO/Co-Ord/B-CDN/Misc.(03)/2023-24/877-902 dated 28-02-2024 on the subject cited above and to state that grievances are being still received in this office from pensioners/family pensioners about the non receipt of Pension Slip.

All CPPCs of Authorized Banks are once again instructed to invariably provide the pension slip to all central civil pensioners and family pensioners after credit pension/family pension through various available modes including e-mail. If email is not available, the same may be obtained from the pensioner so that the pension slip be sent through e-mail also.

2 Government of India, Ministry of Railways, Railway Board, letter No. 2022/E(W)/01/02//5 Dated 04-12-2025 addressed to all General Managers/DGs/CAOs & PUs

Sub: - Complaints regarding non-compliance of Board's letter No. 2022/(W)/01/02/5 dated 03-02-2023 in issuing Post Retirement Complimentary Passed (PRCP)/Widow Passes (WP)

All India Railway men's Federation vide their letter No. AIRF/82(155) Dated 14-04-2025 have brought to the notice of Board the Pass Issuing Authorities across Zonal Railways/PUs are violating instructions in Board's letter dated 03-02-2023 and are not issuing entitled number of PRCPs/WPs to railway employees/their widows who have retired/demised under different PC regimes. Similar request have also been received from various retired railway employees, Pensioners' Associations, etc.

In this context, it is stated that with the approval of the Competent Authority, PRCP entitlement for railway employees retired in the same level under different CPC regimes were rationalised and it was decided that "Status-cum-PLPM" shall be the uniform criterion for PRCP entitlement. The decision was conveyed to all ZRs/PUs vide Board's letter dated 03-02-2023 with directions to refix PRCP/WP entitlement corresponding with the "Status-cum-PLPM" indicated in the PPOs/Revised PPOs. These instructions are reiterated for strict compliance.

3 Government of India, Ministry of Finance, Department of Expenditure, RAJYA SABHA, UNSTARRED QUESTION NO. 252 TO BE ANSWERED ON TUESDAY, DECEMBER 2, 2025

Sub: - Constitution of Eighth Pay Commission

Will the Minister of Finance be pleased to State:

- a) Whether Government has issued notification for constitution of Eighth Central Pay Commission (CPC) recently, the details thereof along with Terms of References (TOR)
- b) Whether Government would merge existing DA/DR with basic pay as an immediate relief measure for Central Government employees/pensioners; if so the details thereof, if not, the reason thereof; and
- c) Whether revision of pension of Central Government employees is not proposed under eighth CPC, the reason there of?

ANSWER MINISTER OF STATE IN THE MINISTRY OF FINANCE, SH. PANKAJ CHOUDHARY

- a) Yes, the Government has notifies Resolution dated 03-11-2025 for constitution of Eighth Central Pay Commission (CPC) along with Terms of Reference (TOR)
- b) No proposal regarding merger of the existing Dearness Allowance with Basic Pay is under consideration with the Government at present.
- c) The Eighth CPC will make its recommendations on the various issues viz. Pay. Allowance, Pension etc. of the Central Government employees.

4 Government of India, Ministry of Finance, Department of Expenditure, LOK SABHA, UNSTARRED QUESTION NO. 1347 TO BE ANSWERED ON DECEMBER 8, 2025.

Sub: - Implementation of 8th Pay Commission

Will the Minister of Finance be pleased to state:

- (a) Whether the Government proposes to implement the 8th Pay Commission with effect from 01-01-2026, if so, the details thereof and action taken there on;
- (b) Whether the Government has finalised the Terms of Reference (TOR) of 8th Pay Commission which will lead

to revision of salaries of Central Government employees and allowance of pensioners, if so, the details thereof and if not, the reason thereof;

(c) Whether the Government proposes to allocate fund for implementing the 8th Pay Commission in 2026-27 budget, if so details thereof and action there on and the total expenditure likely to be incurred from the Government exchequer;

(d) Whether the 8th Pay Commission has consulted/is consulting all major stakeholders including Central Government Employees and pensioners associations, as well as State Governments before taking the recommendations, if so, the details thereof;

(e) The present status of Constitution and other proceedings regarding the setting up of 8th Pay Commission along with the total number of Central Government employees and pensioners benefited;

(f) Whether the Government process to consider the grievances of employees and pensioners due to delay in starting the functioning of 8th Pay Commission, if so, the details thereof; and

(g) The time by which the Pay Commission is likely to submit the recommendations and the time by which the Government implement them?

ANSWER: - MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PANKAJ CHOUDHARY)

(a) (a) to (c), (e) and (f): The 8th Central Pay Commission (CPC) has already been constituted. The Terms of Reference (TOR) of the 8th Pay Commission have been notified vide Ministry of Finance' Resolution dated 03-11-2025. The number of Central Government employees is 50.14 lakh and the pensioner is 69 lakh approximately. The date of implementation of 8th Central Pay Commission shall be decided by the Government. Government will make appropriate provision of funds for implementing the accepted recommendations of 8th CPC.

Sub: - CGHS rates applicable for treatment at healthcare organisation In reference to subject above, and in supersession of all previous memoranda on the subject, the CGHS rates package rates are hereby notified.

1. Implementation of Revised CGHS Rates

These rates will be effective from 13.10.2025 and shall apply to:

a) All healthcare services availed at CGHS-empanelled Healthcare Organisations (HCOs)
 b) Medical Reimbursement Claims of individuals (in r/o Serving, Pensioners and other eligible categories of CGHS beneficiaries).
 c) CGHS, cashless (credit) treatment shall be extended to Central Government pensioners and other specified categories of beneficiaries as per extant rules. The revised rates as per Annexure-I are for the semi private ward entitlement. And are also available on the CGHS website: <https://cghs.mohfw.gov.in>. In exceptional circumstances, where treatment has been availed from any non empanelled private HCOs, reimbursement may be considered as per extant instructions, but the rate would be restricted to Non-NABH (National Accreditation Board for Hospital for Healthcare Providers) rates of the concerned city.

2. Structure of Differential Rates

Revised rates have been rationalised based on accreditation status, hospital type, city classification and ward entitlement:

a) Non-NABH and Non-NABL HCOs: 15% lower than NABH/NABL accredited HCOs. (NABL – National Accreditation Board for Testing and Calibration of Laboratories)
 b) Rates for super speciality hospitals shall be 15% higher than those applicable to NABH- accredited hospitals for the corresponding Super specialities within the same city category.
 c) HCO located in Y (Tier II) cities and Z (Tier III) cities rates shall be 10% and 20% respectively lower than those located in X (Tier I) Cities. Y (Tier II) rates also apply to the HCO located in North-East region and Union Territories of Jammu & Kashmir and Ladakh.
 d) The new package rates mentioned in are for semi-private ward. For general ward there will be a decrease of 5% in the rates, and for the private ward entitlement, there will be an increase of 5% on the applicable admissible claim amount.

e) Rates for consultations, radiotherapy, investigations, day care procedures, and minor procedures not requiring admission shall remain uniform, irrespective of the ward entitlement.
 f) For cancer surgeries, existing CGHS rules and rates continue. However, revised rates apply to chemotherapy, investigations and radiotherapy. (331 Pages)






