

## **TERMS AND CONDITIONS OF EMPANELMENT OF FORTIS HOSPITAL WITH RSCWS**

Fortis Hospital, Mohali have renewed their empanelment with Railway Senior Citizens Welfare Society (RSCWS) for treatment in OPD & IPD – on **CGHS Delhi rates for Super Specialties & some concessions in other areas, for Members of RSCWS.**

Fortis Hospital, Mohali have renewed their empanelment with Railway Senior Citizens Welfare Society (RSCWS) for treatment in OPD & IPD.

**Terms and conditions of Empanelment of Fortis Hospital with RSCWS are as follows:**

**a) For Hospitalization:** Members of RSCWS who are not covered under any insurance, Fortis Hospital Mohali will charge the rates as per CGHS (Super specialized) rates of Delhi for following specialties.

### **Terms Cash**

1. Cardiac (Cardiology and Cardiac Surgery) Package
2. Ortho Joint replacement packages
3. Renal Transplant
4. Chemotherapy
5. Urology surgical Package
6. Ophthalmology surgical Package
7. Laparoscopic surgery Package

**b) Other Multi-Specialties:** For Members of RSCWS who are not covered under any insurance a discount of 10% on prevailing Fortis packages excluding implants. In case a package is not available for a particular specialty or a disease 10% discount on procedure/surgery charges and on non-ICU room rentals will be given on prevailing Fortis tariff.

**c) OPD and Diagnostics:** A discount of 20 % shall be imparted on Consultations, diagnostics & Day care procedures.

For CT and in a case where the test(s) or diagnostic(s) are not available at Fortis and the same needs to be done at a center outside Fortis (in case of some high-end Path Lab tests &/or in case of MRI etc) no discounts shall be imparted. Briefly no discount on Send-outs / Out-sourced Services. **Terms Cash**

**d) Annual Health Check-Up.** A special 10% discount on prevailing health packages is offered. (Annexure –A has details of current health check packages at FHM)

**e) Dental :** **Terms Cash**

1. 20% discount on consultations and dental intra oral x-rays
2. 10% discount on all routine and specialized dental treatment's excluding implants.

**f) No discount on (i) send-outs / Outsourced services (ii) any CGHS approved procedure whatsoever**

g) **VAT & Taxes:** All taxes & duties shall be charged separately as applicable.

h) **The applicability:** The applicability of the association (MOU/Contract) shall be for a period of 1(one) Year from the date of entering into an association and shall stand extended for a further period of 1(one) years on each occasion if no party gives notice of non – renewal, 15 days prior to the expiry of the agreement. The agreement can be terminated by a one months' notice by either side.

i) The rates, as applicable on the date of entering into an association are liable to change resulting into an automatic change in their applicability to the beneficiary even in-between the contract period.

k) Since Fortis Hospital Mohali have a centralized purchase mechanism for all the group hospitals, hence, Fortis Hospital Mohali would not be able to provide purchase invoices of Implants & Medicine.
